TDHCA and Capital Area HFC (CAHFC) Partnership: Additional Down-Payment Assistance for Bastrop, Blanco, Burnet, Caldwell, Fayette, Hays, Lee, Llano and Williamson Counties

The **Texas Homebuyer Program**, offered through the Texas Department of Housing and Community Affairs, is partnering with the **Capital Area Housing Finance Corporation** to make financing a first home more affordable for low to middle-income families. Effective on loan reservations beginning **October 1, 2020**, additional down-payment assistance (DPA) is available for homes purchased in the counties of **Bastrop, Blanco, Burnet, Caldwell, Fayette, Hays, Lee, Llano and Williamson**. These counties are specific to the designated service area/jurisdiction of CAHFC.

The DPA incentive must be combined with the offerings available under My First Texas Home only. Access to these funds is on a first-come, first serve basis and subject to funding availability. The additional DPA will be provided in the form of a **grant** - no repayment required. TDHCA's DPA will continue to be in the form of a deferred-repayable 2nd loan.

Maximum Debt-to-Income: 50.00%
